**KNOWN AS THE ZONING BYLAW**

1. Section 6.4.3 is amended by adding at the discretionary use a Car Wash within the commercial district of Cochin
2. This bylaw shall come into force and take effect when approved by the Resort Village of Cochin Council.

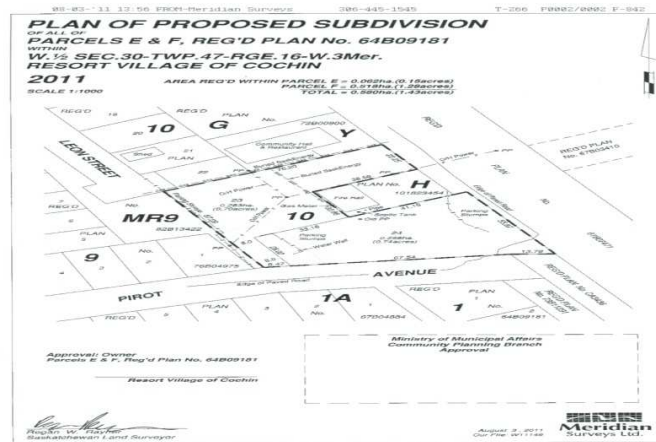

## NOTICE

Public notice is hereby given that the Council of the Resort Village of Cochin intends to adopt a bylaw under The Planning and Development Act, 2007 to amend Bylaw No. 8/89, known as the Basic Zoning Bylaw.

### INTENT

The proposed bylaw will allow a perspective developer to build a commercial carwash enterprise on Proposed Lot 10 (Formally known as Parcel E&F).



### AFFECTED LAND

### REASON

The reason for this amendment is to provide for the development of a new carwash/laundry mat facility in the Resort Village of Cochin.

### PUBLIC INSPECTION

Any person may inspect the bylaw at the village office between 9:00am and 4:00pm excluding weekends and statutory holidays.
